PGY1 PHARMACY RESIDENCY PROGRAM

The purpose of the MWU-CCP Pharmacy Residency Program is to develop a competent and confident generalist able to provide medication therapy management for various disease states. The program provides the majority of experiences in ambulatory care settings and is designed to build upon prior knowledge, skills, attitudes, and abilities in developing professionally mature practitioner-educators. The program is designed to prepare the graduate to pursue positions in PGY2 residency programs, ambulatory care, or academia. The program offers diverse experience in different types of ambulatory care practice settings and disease states. Additionally, considerable time is spent in academia and education, providing residents with a foundation of the principles of teaching and learning — and practical experience to implement what residents have learned. To accomplish this, residents typically spend four days per week at clinical sites throughout the Chicagoland area and one day per week on campus involved in academic activities.

Program Highlights

- Core clinical rotations include experiences in ambulatory care, internal medicine, drug information, and pharmacy services.
- Patient care services include: anticoagulation, diabetes, hyperlipidemia, hypertension, and outpatient internal medicine.
- Rotations are offered in a variety of patient care settings including: academic medical center, community health center, managed care clinic, physician office clinic, and Veterans Affairs hospital leadership
- Participate in lectures, workshops and student precepting

Accreditation Status

Accredited by the American Society of Health-System Pharmacists (ASHP).

Qualifications of the Resident

Applicants must have graduated with the Doctor of Pharmacy degree and be eligible for pharmacist licensure in Illinois. The applicant must be motivated, self-directed, and have excellent communication skills. An interest in teaching is essential.

PGY2 PHARMACY RESIDENCY PROGRAMS

The purpose of the MWU-CCP PGY2 Residency Programs is to transition a PGY1 residency graduate from a general practitioner to an independent specialist in Infectious Diseases or Critical Care. The PGY2 Infectious Diseases residency program is intended to facilitate the development of expertise in the practice of antimicrobial patient-centered care in both the inpatient and outpatient settings. The PGY2 Critical Care residency program develops expertise in the therapeutics and care of critically ill patients.

Program Highlights

Infectious Diseases Residency

- Core clinical residency experiences include: general infectious diseases consults, immunocompromised infectious diseases consults, HIV ambulatory clinic, and antimicrobial stewardship
- Elective clinical experiences may include: critical care, oncology, pediatric infectious diseases, bone marrow transplant, and solid organ transplant
- The primary practice sites for clinical rotations are Northwestern Memorial Hospital and Rush University Medical Center in downtown Chicago.

Critical Care Residency

- Core clinical residency experiences include: MICU, SICU, CCU, neurosciences, and infectious diseases.
- Elective clinical experiences may include: solid organ transplant, toxicology, emergency medicine, pediatric ICU, nutrition, and hematology/oncology
- The primary practice sites for clinical rotations are Northwest Community Hospital in Arlington Heights, IL and Rush University Medical Center in downtown Chicago.

Qualifications of the Resident

Applicants must have graduated with the Doctor of Pharmacy degree and be eligible for pharmacist licensure in Illinois. The applicant must have completed an ASHP-accredited PGY1 residency program.

RESIDENCY PROGRAMS WITH AN EMPHASIS ON EDUCATION

The following components are embedded in all of the Chicago College of Pharmacy residency programs.

- **Skills Seminar Series.** Residents participate in a skills seminar series throughout the year. Seminar topics include: research methods, abstract writing, poster presentations, professional ethics, peer review, health care systems, and personnel management.
- **Teaching and Learning Curriculum (TLC).** The TLC is delivered through mini-seminars, applied activities, and formative assessments throughout the residency program. Didactic teaching is evaluated by both content and delivery experts, and both written and verbal feedback are provided to the resident. The TLC is directed by the College's Center for Teaching Excellence. The goal of the TLC is to provide opportunities for residents to gain the knowledge, attitudes, and skills needed to be effective teachers.
- **Teaching and Learning Activities.** Residents implement what they have learned through the TLC program by teaching in the classroom and in patient care settings. Residents provide instruction in small group workshops and large group didactic teaching. Residents serve as preceptors for an Introductory Pharmacy Practice Experience rotation, where the resident precepts one group of students for one-half day per week for 10 weeks. In the second half of the residency, residents serve as a preceptor for 1-2 students on an Advanced Pharmacy Practice Experience.
- **Pharmacy Management and Leadership Curriculum (PMLC).** The PMLC is designed to support the residents' activities in pharmacy practice. Delivered through a series of seminars and applied activities, residents gain an awareness of personal strengths and describe how to capitalize on their strengths. Management topics include comparing and contrasting management and leadership as well as styles of management. Contemporary issues in pharmacy practice, health care systems and professional advocacy are highlighted.
- **Residency Project.** Each resident must design and complete a project under the guidance of a faculty preceptor who will be identified with the assistance of the program director. The project must relate to pharmaceutical care or pharmacy education and can be either original research, and/or enhancement or evaluation of patient care services.
- **Residency Grand Rounds.** Each resident will present a formal grand rounds presentation. The goal of Residency Grand Rounds is to enhance the participant's ability to present complex concepts and scientific data in a clear concise manner and knowledge regarding the use of drug therapy to treat and prevent disease.
