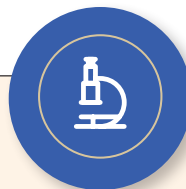

Research Grants: \$2.4 million in 2023/24, the Downers Grove Campus secured \$2.4 million in sponsored research grants, a significant increase from \$1.5 million in 2018/19. This funding enables ground-breaking studies, advancing knowledge in healthcare and other fields.

Fueling Economic Growth

Midwestern University cultivates a highly educated workforce, drives the creation of quality jobs, provides essential healthcare to the community, attracts new visitors to the region, and contributes millions of dollars to the local economy each year.



The 136-acre Downers Grove Campus includes extensive facilities designed to support students pursuing graduate degrees in various healthcare fields, addressing the region's growing demand for skilled professionals. The six-story Multispecialty Clinic, also located in Downers Grove, provides comprehensive care to the community. The University also has a prominent campus in Glendale, Arizona, expanding its reach and impact.

Economic Impact:

As a key economic driver in the region, Midwestern University plays a crucial role in the economic vitality of Downers Grove, DuPage County, and the State of Illinois.

In 2024, the University commissioned a comprehensive, independent analysis by Applied Economics, a specialized economics consulting firm, to determine its current and ongoing financial impact.

\$439 Million Overall Impact

In 2023/24, Midwestern University generated a total economic impact of \$439 million in DuPage County, driven by University operations, local vendor purchases, spending by employees and students, and campus visitors.

Student Spending: \$131.6 Million

Student spending at Midwestern University in 2023/24 generated significant local demand, supporting 581 jobs and \$38.7 million in labor income at local businesses, contributing to the annual economic impact.

687 Direct Jobs and \$86.7 Million Payroll

Midwestern University employs 687 full- and part-time faculty and staff with a total annual payroll of \$86.7 million, providing quality, well-paying jobs for Illinois residents, with 43 percent of employees residing in DuPage County.

Downers Grove, Illinois and DuPage County

\$61.6 Million in Local Vendor Spending and 148 Jobs Supported

Midwestern University supports the local economy by making substantial purchases of equipment, services, and supplies, with \$61.6 million spent in 2023/24. This spending, including \$22.7 million in direct industry-specific purchases, generates an additional \$37.6 million in annual economic impact and supports an estimated 148 jobs in related businesses, contributing \$14.2 million in local labor income.

Construction Expenditures: \$286.1 Million

From FY24 through FY32, Midwestern University is projected to spend \$286.1 million on current and planned construction projects, which could generate a one-time economic impact of \$429 million in DuPage County, supporting approximately 2,647 jobs and \$228.6 million in labor income.

\$55 Million in Employee Spending and 291 Jobs Supported

The 687 faculty, staff, clinic employees, and residents at Midwestern University, along with employees at supported local vendors, contribute significantly to consumer spending, generating an induced economic impact of \$55 million in 2023/24. This spending supports 291 jobs and provides \$19.7 million in labor income for other local businesses.

\$8 Million in University Visitor Spending

Visitors to Midwestern University, including those attending admissions-related events and special University activities, contributed 30,600 visitor days to the local economy. These visitors spent an estimated \$4.8 million on local goods and services such as food, lodging, transportation, retail, and entertainment. This spending resulted in an induced economic impact of \$8.0 million, supporting 80 local jobs and generating \$3.8 million in labor income within the hospitality industry.

State and Local Tax Impacts: \$13.6 Million Midwestern University, as a not-for-profit institution, does not pay local property, sales, or income taxes. However, it generates substantial indirect tax revenues through employee, student, and visitor spending.
